Assignment Overview

Instructional Materials

Each week, you will read chapters from your required eTexts. Short lectures are also provided weekly. In addition to the required reading/viewing, supplemental resources are offered to enrich your learning. Both required and supplemental materials are available in the Instructional Materials topics in the course's Content area.

Discussions

There are eight discussion questions and an ungraded Introduction Discussion. For each discussion question, you are required to post one initial post and two response posts. Be sure to include source citations to support your statements. All posts must use the most current edition of APA format for in-text citations and a reference list.

The initial post must substantively answer the questions posed utilizing concepts or knowledge from the text as well as external research. Examples of external research can be journal articles, government data, online newspapers/magazines, company filings and press releases, etc. Be sure to cite the text and a minimum of one external research source in your initial post.

Substantive response posts must incorporate information from either the text or at least one external research source. The information in your response should further the topic and discussion of the original posting (not "I agree" or "Good job"). Please post early so your classmates can read and benefit from your experiences/ideas.

Your initial post is due by Wednesday at 11:59 pm CT each week. You must respond to at least two of your classmates' postings. Your two responses are due by 11:59 pm CT Sunday per discussion except in Week 8 where they are due by 11:59 pm CT Saturday. You must post an initial post before viewing your classmates' posts.

Each discussion is worth 30 points in total. Each initial post is worth up to 20 points. Each response to your classmates' discussion is worth up to 5 points, for a total of 10 points for responses.

Research Paper

Based on the country you select, you will gather information about this country and provide evaluations in your research paper. In Week 1, you must claim your country by writing it in the "Country Selection" discussion topic by 11:59 pm CT Sunday. You are required to review your classmates' country selections and make sure to select a country not already selected by a classmate to research. Note: You cannot choose the United States as your country to research because you will be asked to compare your selected country to the United States.

There are two parts to the paper:

- Part I: Country Characteristics Research your chosen country based on a list of
 provided questions. All answers should be in complete sentences and provide the
 appropriate amount of context (i.e. no single-word answers). Include a citation in
 the most current edition of APA format for each response, including the direct URL,
 if applicable, after each answer. Be sure to include the date of your information and
 provide the most current data available.
- Part II: Country Evaluation Answer research questions and provide your
 evaluations in a narrative form. For each question, write a minimum of two
 paragraphs with each consisting of a minimum of 115 words equaling a total of 230
 words per question. It should include the proper use of thesis statements,
 paragraph and sentence structure; proper utilization of grammar, including
 punctuation, spelling, subject, and verb usage; and error-free writing.

Be sure to use the most current edition of APA for in-text citations and a reference list. The document should be submitted in MS Word, double-spaced, with consistent 1-inch margins on each page, and in font consistent with current APA guidelines.

Detailed instructions for completing these two parts of the paper are available in the Assignment Expectations topic located in the Start Here module of the course. A grading rubric will be provided in the course Content area. The assignment is worth 240 points and is due by 11:59 pm CT Sunday of Week 7 to the appropriate Dropbox.

Quizzes

Every week except for Weeks 4 and 8, you will have a quiz composed of multiple-choice and/or true/false questions covering the chapters for that week. The quizzes are available from Wednesday until 11:59 pm CT on Sunday of the assigned week (except in Week 8 when the quiz is due Saturday). The quizzes are comprised of 22 questions each and are worth 44 points. You will have 33 minutes and only one attempt to work on each quiz.

Exams

There are two exams in this course: a Midterm Exam and Final Exam. Both exams are open-book. You may use your notes and textbook.

You will take a Midterm Exam composed of 53 multiple-choice and/or true/false questions covering all chapters assigned through Week 4. Each question is worth 2 points for a total of 106 points. The exam is available from Wednesday until 11:59 pm CT on Sunday of Week 4. You will have 80 minutes and only one attempt to work on the exam.

You will take a comprehensive Final Exam covering the chapters assigned throughout the session. The exam is composed of 75 multiple-choice and/or true/false questions and is worth 150 points. The exam is available from Wednesday until 11:59 pm CT on Saturday of Week 8. You will have 113 minutes and only one attempt to work on the exam.
