#### **Textbook Information**

## **Assignment Overview**

#### **Instructional Materials**

For this course, you are expected to read at least a chapter each week along with a short selection of lectures and articles available in the course. Each of the weekly instructional materials includes timely lecture topics with optional resources (videos, articles, etc.) for your review.

#### **Discussions**

Each week, you'll have two discussions. To fully grasp religion and human experience, you will have to have a level of understanding far beyond simple recall. You must read and discern the materials and then apply these materials to your life. Discussion topics should challenge you to ensure that the concepts can be analyzed, synthesized and, in some cases, defended.

Your initial response for each discussion is due by Thursday at 11:59 pm Central Time (CT). In addition, you must make at least two follow-up responses per discussion to your classmates or my posts as appropriate. All response posts are due by Sunday, 11:59 pm CT, except in Week 8, response posts will be due by Saturday at 11:59 pm CT. You must post your initial response to a discussion before you will be able to see other responses. Each discussion is worth 10 points. Full expectations are provided in the course.

#### Dropbox

There are two 40-point Dropbox assignments in this course, due Sunday of Weeks 3 and 7 at 11:59 pm CT. Each Dropbox requires you to create 20 multiple-choice test questions from the readings. Dropbox 1 will cover Chapters 1, 2, 3, 19 and, if you wish, 4. Dropbox 2 will cover Chapters 6, 10, 11, and, if you wish, 12. Full details on this assignment are provided in the course.

#### Quizzes

There will be six quizzes with 20 questions. The weekly quizzes will assess your learning from the weekly readings and other course materials. Questions on the quizzes are a combination of multiple choice, matching, and true/false questions. Some true/false questions will require reading comprehension.

For each 40-point quiz, you will have only one attempt with a 40-minute time limit. Quizzes will open at the start of the week and close at 11:59 pm CT on Sunday of the week it is assigned.

#### **Exams**

There will be two exams, a Midterm in Week 4 and a proctored Final in Week 8 to challenge your comprehension, understanding, and application of the readings, discussions, and Dropbox assignments from the course. The final is comprehensive. The questions on both exams are a combination of multiple choice, matching, and true/false. Some true/false questions will require reading comprehension.

The Midterm is not proctored. It will cover materials from the first four weeks of the class. There will be 50 questions, worth two points each. There will be a one-hour time limit on this exam.

The Final is proctored. It will cover materials from the entire course (all eight weeks). There will be 100 questions, worth two points each. There will be a two-hour time limit on this exam.

Exams will open at the start of the week. The Midterm will close at 11:59 pm CT on Sunday of Week 4 and the Final will close at 11:59 pm CT on Saturday of Week 8.
